Mastermind® Variant Data License Agreement

Genomenon®, Inc. ("Genomenon") has compiled or will compile a list of genomic variants found within Genomenon's Mastermind® Genomic Search Engine and a count of published articles in the Mastermind® database within which such genomic variants are referenced (collectively, "Mastermind® Variant Data" and the file within which such Mastermind® Variant Data is stored, the "Cited Variant Reference File").

BY DOWNLOADING, USING OR ACCESSING THE MASTERMIND® VARIANT DATA OR CITED VARIANT REFERENCE FILE, YOU ("Licensee") ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTOOD THIS MASTERMIND® VARIANT DATA LICENSE AGREEMENT("Agreement"), ACCEPT THIS AGREEMENT AND AGREE THAT YOU ARE LEGALLY BOUND BY ITS TERMS. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT DOWNLOAD, USE OR ACCESS THE MASTERMIND® VARIANT DATA OR THE CITED VARIANT REFERENCE FILE.

1. <u>License Grant</u>. Subject to Licensee's compliance with the terms and conditions of this Agreement, Genomenon hereby grants Licensee a limited, non-exclusive, non-assignable, non-sublicenseable, non-transferable, revocable license to access the Cited Variant Reference File, incorporate some or all of the Mastermind® Variant Data, as provided by Genomenon, into Licensee's software, application or website and publish and display the Mastermind® Variant Data, as provided by Genomenon, to third parties in connection with Licensee's commercial use ("**Permitted Use**").

2. Use Restrictions.

- (a) Licensee shall only use the Mastermind® Variant Data and Cited Variant Reference File for the Permitted Use. Any purpose or use not specifically authorized herein is prohibited unless otherwise agreed to in writing by Genomenon.
- (b) Without limiting the foregoing and except as otherwise expressly set forth in this Agreement, Licensee shall not at any time, directly or indirectly: (i) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available the Cited Variant Reference File; (ii) reverse engineer, disassemble, decompile, decode, adapt, or otherwise attempt to derive or gain access to the source of the Mastermind® Variant Data or methods used to compile the Mastermind® Variant Data, in whole or in part; (iii) remove any proprietary notices included within the Mastermind® Variant Data or Cited Variant Reference File; (iv) publish, enhance, or display any compilation or directory based upon information derived from the Mastermind® Variant Data or Cited Variant Reference File in any manner or for any purpose that competes with Genomenon, its business or Genomenon's Mastermind® Genomic Search Engine, or infringes, misappropriates, or otherwise violates any intellectual property right or other right of any person, or that violates any applicable law.
- (c) As a condition precedent to any publication or display of the Mastermind® Variant Data by Licensee consistent with the Permitted Use, Licensee shall include with such publication and/or display, in a reasonably prominent and good faith manner so as to appropriately credit Genomenon and Genomenon's Mastermind® Genomic Search Engine: (i) a reference to Genomenon's Mastermind® Genomic Search Engine; (ii) recognition of the contributions of Genomenon and use of Genomenon's Mastermind® Genomic Search Engine; and (iii) a hyperlink to Genomenon's Mastermind® Genomic Search Engine.
- 3. Reservation of Rights. Genomenon reserves all rights not expressly granted to Licensee in this Agreement. Except for the limited rights and licenses expressly granted under this Agreement, nothing in this Agreement grants, by implication, waiver, estoppel or otherwise, to Licensee or any third party any intellectual property rights or other right, title or interest in or to the Mastermind® Variant Data or Cited Variant Reference File.

- 4. Intellectual Property Ownership; Feedback.
- (a) Licensee acknowledges that, as between Licensee and Genomenon, Genomenon owns all right, title and interest, including all intellectual property rights, in and to the Mastermind® Variant Data and Cited Variant Reference File. Licensee further acknowledges that: (i) the Mastermind® Variant Data is an original compilation protected by United States copyright laws; (ii) Genomenon has dedicated substantial resources to collect, manage and compile the Mastermind® Variant Data and Cited Variant Reference File; and (iii) the Mastermind® Variant Data constitutes trade secrets of Genomenon. Genomenon may terminate this Agreement without advance notice to Licensee or an opportunity for Licensee to cure and without further obligation or liability if Licensee contests any of Genomenon's right, title or interest in or to the Mastermind® Variant Data or Cited Variant Reference File, including, without limitation, in a judicial proceeding anywhere throughout the world.
- (b) Licensee acknowledges and agrees that submission of any ideas, suggestions, documents, proposals, improvements, modifications, error identifications, content corrections or additions, variant classifications, suggestions for publications, recommendations of outside databases, opinions regarding the appropriateness of a particular curated article to the clinical assessment of one or more variants or other content or information related to Genomenon, its business, the Mastermind® Variant Data, the Cited Variant Reference File or Genomenon's Mastermind® Genomic Search Engine (collectively, "Feedback") to Genomenon is at Licensee's own risk and that Genomenon has no obligations (including without limitation obligations of confidentiality or use) with respect to such Feedback. Licensee represents and warrants that Licensee has all rights necessary to submit the Feedback to Genomenon. Licensee hereby grants to Genomenon a fully paid, royalty-free, perpetual, irrevocable, worldwide and non-exclusive right and license to use, copy, reformat, display, perform, modify, disclose, distribute, adapt, create derivative works of, and otherwise commercially or non-commercially exploit in any manner, any and all Feedback and to sublicense the foregoing rights.

GENOMENON SPECIFICALLY DISCLAIMS ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT, AND ALL WARRANTIES ARISING FROM COURSE OF DEALING, USAGE AND TRADE PRACTICE. GENOMENON MAKES NO WARRANTY OF ANY KIND THAT THE MASTERMIND® VARIANT DATA, THE CITED VARIANT REFERENCE FILE OR ANY PRODUCTS OR RESULTS OF THEIR USE WILL MEET LICENSEE'S OR ANY OTHER PERSON'S REQUIREMENTS OR EXPECTATIONS, OPERATE WITHOUT INTERRUPTION, ACHIEVE ANY INTENDED RESULT, BE COMPATIBLE OR WORK WITH ANY SOFTWARE, SYSTEM OR OTHER SERVICES OR BE SECURE, ACCURATE, COMPLETE, FREE OF HARMFUL CODE OR ERROR FREE.

Licensee shall indemnify, hold harmless and, at Genomenon's option, defend Genomenon from and against any and all losses, damages, liabilities and costs (including attorney fees) resulting from or arising out of Licensee's negligence or willful misconduct, breach of this Agreement or use of the Mastermind® Variant Data or Cited Variant Reference File in a manner not authorized by this Agreement, provided that Licensee may not settle any indemnified claim unless such settlement completely and forever releases Genomenon from all liability therefor or unless Genomenon consents to such settlement, and further provided that Genomenon shall have the right, at its option, to defend itself against any indemnified claim or to participate in the defense thereof by counsel of its own choice.
- 7. <u>Termination</u>. In addition to termination rights described in section 4(a), Genomenon may terminate this Agreement without advance notice to Licensee or an opportunity for Licensee to cure and without further obligation or liability if Licensee is in material breach of, or has materially breached, this Agreement. Upon termination of this Agreement, the license to the Mastermind® Variant Data and the Cited Variant Reference File granted hereunder will also terminate, and, without limiting Licensee's confidentiality obligations, Licensee shall cease using and delete, destroy, or return all copies of the Mastermind® Variant Data and Cited Variant Reference File and certify in writing to Genomenon that the Mastermind® Variant Data and the Cited Variant Reference File has been deleted or destroyed. Any rights, obligations or required performance of the parties in this Agreement which, by their express terms or nature and context are intended to survive termination or expiration of this Agreement, will survive any such termination or expiration, including the rights and obligations set forth in this Section 7 and Sections 3, 4, 5, 6 and 8.

8. Miscellaneous.

- (a) This Agreement constitutes the sole and entire agreement of the parties with respect to the subject matter of this Agreement and supersedes all prior and contemporaneous understandings, agreements, and representations and warranties, both written and oral, with respect to such subject matter. Nothing express or implied in this Agreement is intended to confer, nor will anything herein confer, upon any person other than Genomenon and Licensee and their respective successors and permitted assigns any right, remedies, obligations or liabilities whatsoever. The United Nations Convention on Contracts for the Sale of Goods will not apply to this Agreement,
- (b) No amendment to or modification of this Agreement is effective unless it is in writing and signed by an authorized representative of each party. No waiver by any party of any of the provisions hereof will be effective unless explicitly set forth in writing and signed by the party so waiving. Except as otherwise set forth in this Agreement, (i) no failure to exercise, or delay in exercising, any rights, remedy, power or privilege arising from this Agreement will operate or be construed as a waiver thereof and (ii) no single or partial exercise of any right, remedy, power, or privilege hereunder will

preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

- (c) If any provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability will not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal, or unenforceable, the parties hereto shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.
- (d) This Agreement is governed by and construed in accordance with the internal laws of the State of Michigan without giving effect to any choice or conflict of law provision or rule that would require or permit the application of the laws of any jurisdiction other than those of the State of Michigan. Any legal suit, action, or proceeding arising out of or related to this Agreement or the licenses granted hereunder will be instituted exclusively in the federal courts of the United States or the courts of the State of Michigan in each case located in the city of Ann Arbor and County of Washtenaw, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action, or proceeding.
- (e) Licensee may not assign or transfer any of its rights or delegate any of its obligations hereunder, in each case whether voluntarily, involuntarily, by operation of law or otherwise, without the prior written consent of Genomenon. Any purported assignment, transfer, or delegation in violation of this Section is null and void. No assignment, transfer, or delegation will relieve the assigning or delegating party of any of its obligations hereunder. This Agreement is binding upon and inures to the benefit of the parties hereto and their respective permitted successors and assigns.
- (f) Licensee acknowledges and agrees that a breach or threatened breach by Licensee of its obligations in relation to the license granted hereunder would cause Genomenon irreparable harm for which monetary damages would not be an adequate remedy and agrees that, in the event of such breach or threatened breach, Genomenon will be entitled to equitable relief, including a restraining order, an injunction, specific performance and any other relief that may be available from any court, without any requirement to post a bond or other security or to prove actual damages or that monetary damages are not an adequate remedy. Such remedies are not exclusive and are in addition to all other remedies that may be available at law, in equity or otherwise.
